January 10th - Meeting Agenda

- **Introductions of any guests or new Partnership members**
 - Mike Shorter of Clubhouse Indiana shared about their programs and services. Currently in discussion with MHAHC about potentially starting a Clubhouse in Hendricks County.  - Minkah Becktemba shared more about Multiple Pathways to Recovery's peer coaching services.
 - Chenay Daily of the Hendricks County Phoenix Collaborative introduced herself and outlined the agencies' programs and services, which include providing trauma-informed care and resilience building workshops for parents and caregivers.
 - William Lavalley and Elena Guadiana of Anthem's Medicaid Outreach team introduced themselves and shared about the services they can offer to interested partners, including Medicaid 101 presentations, connection assistance for clients seeking to apply for Medicaid. **Note both William and Elena are bilingual and happy to offer their services in Spanish.

- **Main Discussion: New Resource Guide Premier (Michael Aviah)**
 - Michael shared an outline of the logic-model that has guided his ongoing edits to the new Online Community Resource Guide. He also shared 3-4 visual walk-through examples of what the updated guide will look like, and how it will be searchable based on whatever needs a client may have, and their responses to follow-up search filters. Expected full rollout by late Spring this year.
